

# Ice rink Gothál

## TERMS OF USE

Terms of use serve for compliance with corresponding legal norms in terms of use of the facility, safety and protection of health of visitors of mobile Ice rink Gothál, situated in Gothál resort in Liptovská Osada, Liptovská Osada 756, 034 73. Each visitor shall read these terms of use prior to entering the ice rink and follow its provisions. The visitor expresses explicit consent with these terms of use by payment of entrance fee or by other authorised entrance and shall comply with its provisions and instructions of employees of the operator. Furthermore, one shall inform all accompanying juvenile persons about these terms of use. Current instructions are superordinate to terms of use in case of mobile ice rink and follow general hygiene and safety regulations. Visitors shall refrain from any behaviour, which may disturb the comfort of other visitors or disturb the employment duties of employees.

**Ice rink Gothál** shall serve for free skating, sport activity of natural persons as well as for children from primary or nursery schools. Operating hours and maintenance schedule may be adjusted due to snow layer on ice, quality of ice and weather conditions (rain, snow, strong wind), or due to events organised by the company.

### I. ENTRANCE to Ice rink Gothál

The entrance to ice rink is only allowed during operation hours, only with valid ticket – bill, which shall be bought at the reception of Water world. The visitor may be asked to show the ticket to a responsible person of the operator.

- ⚙ The paid ticket is valid for a period of 3 hours
- ⚙ Information about the operating hours of the ice rink and price list shall be provided at the cash desk as well as on website: **[www.gothal.sk](http://www.gothal.sk)**
- ⚙ The operating hours of the ice rink is daily from 10:00 to 19:00. The operating hours may be changed by the operator in case of unsuitable conditions.
- ⚙ Sale of tickets begins at 10:00 and ends 30 minutes before closing hours. It is strictly prohibited to enter the ice rink after the operating hours.
- ⚙ Visitors shall follow instructions of the operator and other employees working on ice rink.
- ⚙ Entrance to the ice rink is only at your own responsibility
- ⚙ Children below 6 years of age shall only enter the ice rink accompanied by a legal representative, a person older than 18 years of age, which either has ice skates or uses sport shoes. Entrance with other shoes is prohibited.
- ⚙ The accompanying person is responsible for the children during the whole stay within the premises of ice rink. In case of breach of terms of use or other restrictions and instructions, the operator shall not be held liable for any accidents or injuries of children.

- ⚙ Children below 12 years of age shall use the ice rink under the supervision of a person older than 18 years of age.
- ⚙ The corresponding teacher or team lead shall be responsible for persons below 15 years of age during out-of-school activity. At other times, the legal representative shall be responsible for these persons.
- ⚙ The operator reserves the right to limit or close the ice rink premises in case of necessary maintenance or due to objective reasons (full capacity, bad weather) without the right to claim refund of entrance ticket, or its proportional amount. It is prohibited to use the ice rink in the determined area when such restrictions apply.
- ⚙ The capacity of a mobile ice rink is 100 persons.

## **II. SKATING RULES**

- ⚙ Entrance to the ice rink is only allowed with special sport gear – ice skates and suitable apparel.
- ⚙ Entrance to the ice rink is only allowed through the dedicated entrance, not by jumping over the boards.
- ⚙ It is prohibited to jump over the boards and sit on the boards.
- ⚙ Skating on the ice rink is only allowed in the determined direction, with appropriate speed.
- ⚙ Less skilled skaters shall move cautiously in their own interest on ice, or in the central section of ice rink such that they don't interfere with other skaters and prevent accidents.
- ⚙ It is recommended to wear a cap, helmet and gloves.
- ⚙ It is prohibited to chase, trip and skate in a manner which may endanger the safety of other visitors. Most common accidents of undisciplined skaters are cuts, head injuries and fractures.
- ⚙ The visitors of mobile ice rink shall follow the operating hours and after completion of skating block, they shall leave the ice rink and respect instructions of the responsible employee.
- ⚙ It is strongly prohibited to stay on ice during the maintenance of the ice rink or outside of operation hours.

## **III. OPERATIONS INSTRUCTIONS FOR VISITORS**

- ⚙ Responsible employee is entitled to verify if the person skating in the ice rink has a valid ticket to do so.
- ⚙ Each visitor shall ensure protection and safety of his/her health as well as protection and safety of other visitors.
- ⚙ There are benches available next to ice rink on rubber floor.
- ⚙ The operator requests visitors not to carry valuable items and larger sums of money. The operator does not offer storage of items and shall not be liable for any loss, destruction or damage of items.

- ⚙ The visitors shall return all items found on the ice rink without undue delay to the responsible employee of the mobile ice rink or at the reception of Water world.
- ⚙ Visitors shall carefully use any equipment and facility of the ice rink. Damage of property of the operator or properties of third parties caused by their action (deliberate or accidently) shall be reimbursed.
- ⚙ Skating on ice is at your own responsibility. The operator shall not be held liable for any injury and accidents caused by own negligence, carelessness or breach of terms of use.
- ⚙ The teacher or team leader shall be responsible for possible injuries on ice during skating of organised group of children.
- ⚙ In case of injury, accident or indisposition a visitor shall immediately call the responsible employee for the purposes of treatment or writing a record of the injury.
- ⚙ The first aid kit is located at the reception of the Water world.

#### **IV. RESTRICTIONS AND WARNINGS IN GOTHAL AREA**

- ⚙ The visitors shall adhere to instructions and restrictions on information boards or by other warnings and shall not damage or remove them.
- ⚙ It is strongly prohibited to take food, drinks or chewing gums to ice rink.
- ⚙ It is strongly prohibited to smoke in the whole area, apart from the places designated for it.
- ⚙ It is strongly prohibited to open fire.
- ⚙ Pets are strongly prohibited from entering the ice rink.
- ⚙ It is strongly prohibited to take narcotic drugs, sharp or glassy items, dangerous, chemical and explosive substances.
- ⚙ It is strongly prohibited to carry any type of guns in Gothál resort in Liptovská Osada and to use them.
- ⚙ Littering is strongly prohibited in the area of mobile ice rink and its surroundings. There are waste bins available in the ice rink area.
- ⚙ It is prohibited to annoy other visitors by one's behaviour, to make unnecessary noise, to chase or hit other persons on ice and skate against the determined direction of skating.
- ⚙ It is prohibited to use puck, ball or hockey sticks etc.
- ⚙ Persons showing significant signs of consumptions of alcoholic drinks or psychotropic substances and who endanger the safety of other visitors by their behaviour or cleanness in the area of ice rink are prohibited from entering the ice rink.
- ⚙ The visitors shall not manipulate with machinery and electrical devices related to ice rink.
- ⚙ It is prohibited to take photos or film other people or groups of people without their consent. Taking photos and filming for commercial purposes is only allowed based on prior consent of the operator.

#### **V. EXPULSION OF VISITOR FROM THE PREMISES OF MOBILE ICE RINK**

- ⚙️ A visitor can be expelled from the premises of mobile ice rink without the right to claim refund of entrance fee, if one does not comply with given instruction by the corresponding employee of the operator even after being warned, if one does not comply with terms of use and behaves aggressively and uncontrollably, breaches provisions of terms of use and one's behaviour is in breach with legal and social norms.
- ⚙️ Based on the severity and nature of the offence by the visitor, the operator may ask for assistance of the security officer or Police.
